We'll stay in the center of all the excitement! The Hyatt Regency is perfectly located in the heart of Columbus, within minutes of some of the city's major attractions. Fodor's Travel Guide describes Columbus as one of the "overlooked and underrated places to visit ... a place that enlivens the spirit and after visiting [it] you're torn between the excitement of sharing your experience with others and the fear of exposing your discovery." That's Columbus. Climb aboard for a mini-tour.

Just south of town is the German Village, a charming restored 19th century neighborhood containing beautifully renovated homes, shops and restaurants. Neighboring the German Village is the Brewery District. Established by German immigrants in the early 1800s, it thrived until the Prohibition era. The many microbreweries and sidewalk cafes demand a

Don't forget to visit the Anheuser-Busch Brewery just north of town and sample some of the beer that has been brewed here since 1968.

Just blocks from the hotel is the new Nationwide Arena. home of the NHL expansion team, the Columbus Blue Jackets. The surrounding Arena District is a pedestrian-friendly "urban village" featuring several restaurants, brewpubs, shops, and a movie cinema. Turn north onto High Street and you've stepped into Short North. This popular revitalized urban neighborhood offers the city's largest, most eclectic concentration of art galleries, restaurants and night spots. Short North hosts monthly gallery hops on the first Saturday and is a great place to shop, dine, or dance the night away.

A short drive northeast of downtown brings you to the recreated 19th century Ohio Village and the boyhood home of humorist James Thurber. This living cultural center is an adventure back in time for young and old alike.

If you prefer more wildlife,

then visit the Columbus Zoo and Aquarium, where famed late-night television animal guy Jack Hanna is Director Emeritus. Next door is Wyndot Lake, a water park adjacent to the zoo with more than 69 thrilling rides, slides, and attractions for all ages.

COSI is the city's science center featuring eight interac-



tive "Learning Worlds", a seven story Extreme Screen Theater and a 21st century planetarium. It's been dubbed the "Kingdom of Learning" by Time.

There's so much, from the Park of Roses (one of the largest in the country) to the Longaberger Homestead and dare ! forget, Ohio State University. You'll just have to join us to experience it all.

The 69th Kfeirian Reunion in Las Vegas was exceptional! The Board of Trustees should be very proud! We must continue to capitalize on the enthusiasm that was created in Las Vegas and build upon it to insure the success of our future reunions. One of the greatest pleasures was the large number of "missing" Kfeirians that attended the Las Vegas Reunion. The Board is dedicated to finding new ways of attracting and retaining our brethren and invigorating our reunions. Las Vegas helped achieve just that.

This past year, the Board of Trustees voted to change some of the conventions associated with the Reunions. # General Assembly News 2001

The Treasurer's report indicated a checkbook balance of \$19,045.39 and Assets balance of \$62,913.67 as of July 10, 2001. Contributions were received in the amount of \$1,835.00 for the Endowment fund and Memorial Contributions of \$430.00. The Palmerian Society (Lebanese Men's Organization) and the Benevolent Society (Lebanese Women's Organization) donated a total of \$6,500.00.

The Board welcomed Mr. Simon Naufel from kfeir, Michael Abourezk from Ottawa and Issam Thabet from Abu Daubi as well as other visitors.

We are still pursuing the retrieval of genealogical information in Kfeir. The Board hopes to find these and preserve the information onto CD-Rom for use of future generations. Jim Abourezk and Simon Naufel offered to assist in the recovery of this information.

Jim Abourezk, former U.S. Senator and Congressman from South Dakota, stated that on a recent trip to Kfeir, he was received by the entire village. The Village put forth many requests and hoped

that our Foundation could help them, starting with a playground for the children. The Kfeirian Reunion has funded many projects for Kfeir including supplying water, electricity, roads, church donations, etc. A standing committee was appointed to research and handle special projects in Kfeir on an annual basis. Members of the committee include Sue Abourezk Folley, Pam Newey, Adeeb Sadd, Jim Abourezk, and Simon Naufel.

Matthew Bassiet and Selma Edinger Basset have taken over responsibility for the mailing list. This is an ongoing and drawn out process. Please forward any corrections to Matthew Bassiet at 790 Bryden Road, Columbus, Ohio 43205.

The website will be maintained by Kevin Donley, who also serves as head of the genealogy project. Becky Thabet-Schulze took over the newsletter when Diann Michael stepped down.

Outgoing Board members include George Hanna, Christy McCoy, Mitchell Mickel, and Stephen Ramey. Newly elected Board Members are George Hanna, Jim Donley, and Abe Basset.

# **Annual Board Meeting News 2001**

The Board of Trustees voted to solicit nominations for the vacancy on the Board based on Section Five of the Constitution entitled: "Vacancies". It reads: Vacancy caused by death, resignation, or otherwise, may be filled by a majority vote of the Board of Trustees for the unexplored term or until an election to fill such vacancy is held by the members of the General Assembly. The Board agreed to resolve the issue in the next 30 days. [Vote taken on August 26, 2001, resulted in the election of Charlie Thabet as the 12th Board member.]

Discussion of the Scholarship applications ensued. George Hanna stated that the applications were not due until August  $1^{\rm st}$  and that Marshall University will review the application at that time and make recommendations based on merit and need.

Becky Thabet-Schulze reported that the hotel set the banquet on Saturday night for 282. The hotel stated that they served more than 300 people.

Newly elected officers of the Kfeirian Reunion Foundation Board of Director's are: President Matthew Bassiet, Vice-President, Phil

Sadd, Treasurer George Hanna, and Secretary Selma Edinger. George Hanna reported that \$6500 was contributed to the Foundation from two Huntington groups that have since dissolved.

Diann Michael is heading up a Kfeirian Cookbook honoring the women of Kfeir and their descendants. She is currently researching options for the Board to consider.

Gregg Barrett, a visitor to the Board meeting, a fund raiser by trade, and a Kfeirian, gave information regarding fund raising and offered his assistance to the Reunion. The Board appointed Matthew Bassiet, Jim Donley, Abe Bassett\* and Pam Newey to a fund raising committee.

Based on the survey from the Saturday night banquet, Columbus, Ohio, was chosen as the site for the 70th reunion. Various venues were entertained for the 2003 reunion including Fort Lauderdale, Florida, a cruise, a beach city, or Washington D.C.

George Hanna thanked Diann Michael on behalf of the Board for all her hard work as President of the Board of Trustees.

#### HISTORY OF A CHURCH BELL

#### A History of Church Bell at St. George Orthodox Church Kfeir, Lebanon

In early 1925, Nicholas and Katra Bassett passed away within five months of each other. Their son, Phillip Bassett, a successful business man in the United States, was forced to return to his native village of Kfeir, Lebanon, to take care of and rear his sibling sisters, Emily, Nazik, Nouha, Asma, and Elaine. Nazik, now Nazik Hanna, and Asma, now Asma Hodge are the only two of these sisters that are still alive today.

St. George Orthodox Church in Kfeir purchased a bell to be housed in the tower on the church roof, however, the church did not have enough money or the means to have the bell shipped to Kfeir. While tending to his siblings, Mr. Bassett offered to travel to the bell manufacturer in Lebanon and brought the bell back at his own expense to Hasbaya.

The bell had been driven by car by Mr. Bassett to Hasbaya, but, in 1925-26, roads did not extend from Hasbaya to Kfeir. How to get the bell to Kfeir? Well Mr. Bassett gathered several young men from the village. Salem Kassab (now 101 years old), Toufic Saad, Moussa Hanna, Ramez and Fayez Bassett, Kamel Basset, Michael Nassar, Eliz Abou Jamra and others built a wooden platform. The placed the bell on the platform and hoisted it upon their shoulders. They sang songs to keep their minds off how heavy the load was as they journeyed the ten mile trek up the steep terrain of the mountain to the church. When they reached the outskirts of Kfeir, the townspeople greeted them with cheers and escorted them with song to St. George Orthodox Church.

Some very interesting things were noted when reading A SNAPSHOT OF KFEIR by Michael el-Hage in 1991 as it reported that:

"Offical name of Kfeir: appears on government maps and documents as Kfeir El-Zait, Kfeir Zait, El-Kfeir, and Kfeir, but we Kfeirians call it Kfeir." It's dimensions are 2 miles east-to-west and 3/4 mile north-to-south and is located in South Lebanon in the foot hills of Mount Hermon. Also reported: that there are four employees in the mail center and it is frequently paralyzed, but mail does frequently arrive. For all practical purposes there are no taxes. (Don't everyone head back at once). There are five members of council and a president, but no government funds are available to the council for improvement projects. The chief entertainment is card playing and gossip. Social affairs and politics are discussed in the grocery stores in an open forum. Lebanon Power and Light furnishes electricity only 12 hours out of 36. There is no telephone system. There is no sewer system. Each home has a primitive septic system. The average Kfeiran laborer is a Jack-of-alltrades. Honey, olives and olive oil produced in Kfeir is considered the highest quality available in Lebanon. There are no restaurants or coffee shops, only a cafeteria on the school grounds. serving short orders.

## Czech this out! A Young Czech in America by Jim Donley



Zuzana and her neice, Shannon Donley (great granddaughter of Jim Monsour Thabet), danced the night away.

In June, 2001, a young girl was about to embark on an adventure beyond her wildest dreams. Zuzana Misakova (pronounced Zoo-zon-ah Me-sha-co-va), my 9 vr. old half sister-in-law, was coming to America. She was leaving her native Czech Republic and traveling across the ocean for the first time. She was leaving a small village where beef is rarely sold. where horse-drawn carts can still be seen traversing the roads and where telephones are a luxury. Her teacher let her leave

school early because of the education she would receive visiting the U.S. Her fellow classmates only had one request for her .... Tell them how Disneyland is!

Her first weekend was in New York City. The tallest skyscraper she had seen up to that point was the 10 story apartment building she lived in. The more we walked, the more her neck got cramped from looking up. Her visit to FAO Schwartz's world famous toy store was equivalent to St. Nicolas coming to her house 365 days out of the year. She couldn't leave without buying a bubble maker. After an afternoon on Ellis Island to do Thabet research and ending up hitting the jackpot on my wife Ivana's side, we finished the day in typical Czech fashion..... walking. We walked nearly half the way across Manhattan, from the docks all the way to 53rd.... a drop in the bucket for Czechs... a workout for Americans!

No trip would be complete without a visit to my family in Detroit. En route to my hometown, I introduced Zuzana to the nice police in Ohio and demonstrated to her what it is like getting a speeding ticket. Zuzana's introduction to a July 4th party with my nieces and nephews showed us that anyone can overcome the language barrier. They played in a kiddie pool for hours even though Zuzana had to watch as she had no bathing suit. While Ivana and I tried to prevent the kids from splashing water on Zuzana's clothes, she felt otherwise and jumped in the water clothes and all! Additional entertainment was spent visiting the grocery store as Zuzana marveled at the dozens of cereal boxes and ice creams that lined the shelves.

After many weeks in Washington D.C. learning about who Abraham Lincoln was and drinking tootie fruitie drinks, we were finally off to Las Vegas where Zuzana surely left her mark. She spent her hours by the pool (during her visit to the U.S., she spent an average of 5 hrs a day by a swimming pool!) and tried to adjust to the sweltering heat. 
#### Other Mini-Reunions in the works...
